

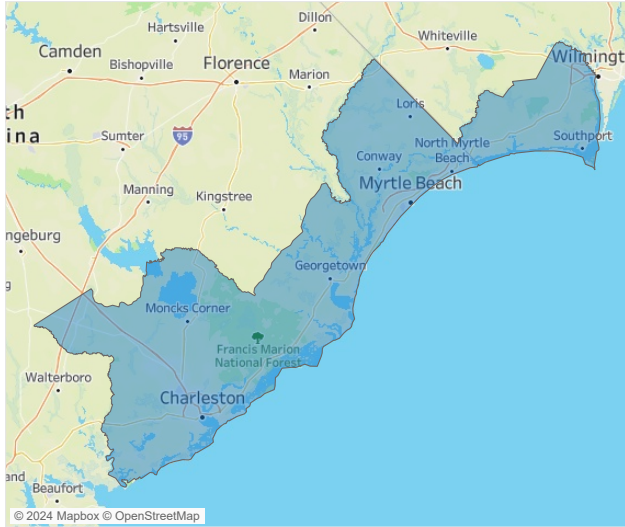

Charleston is the **54th** largest multifamily market with **82,255** completed units and **31,366** units in development, **9,475** of which have already broken ground.

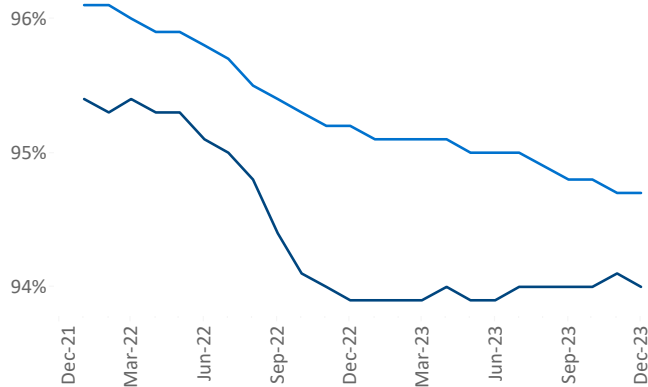
New lease asking **rents** are at **\$1,731**, up **2.4%** ▲ from the previous year placing Charleston at **49th** overall in year-over-year rent growth.

Multifamily housing **demand** has been positive with **4,517** ▲ net units absorbed over the past twelve months. This is up **778** ▲ units from the previous year's gain of **3,739** ▲ absorbed units.

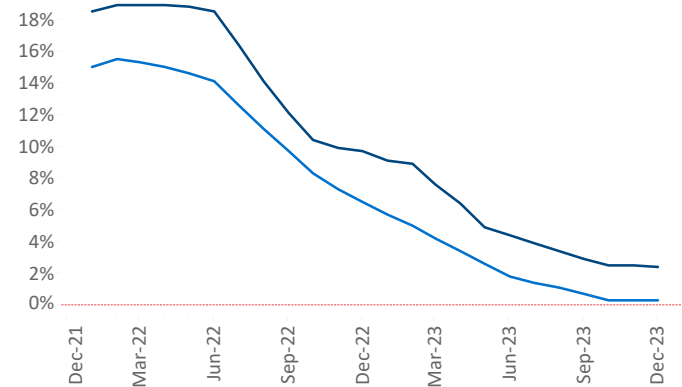
Employment in Charleston has grown by **4.6%** ▲ over the past 12 months, while hourly wages have risen by **3.6%** ▲ YoY to **\$30.92** according to the *Bureau of Labor Statistics*.

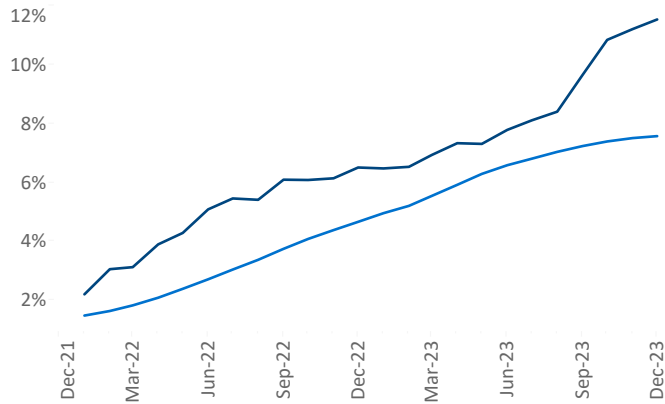
Occupancy
