Lansing - Ann Arbor is the **45th** largest multifamily market with **108,011** completed units and **16,209** units in development, **2,722** of which have already broken ground.

Advertised **rents** are at **\$1,247**, up **3.5% ▲** from the previous year placing Lansing - Ann Arbor at **27th** overall in year-over-year rent growth.

Multifamily housing **demand** has been positive with **1,224 ▲** units absorbed over the past twelve months. Absorption decreased by **-7 ▼** units from the previous year's absorption gain of **1,231 ▲** units.


Employment in Lansing - Ann Arbor has grown by **1.3% ▲** over the past 12 months, while hourly wages have risen by **2.9% ▲** YoY to **\$31.75** according to the *Bureau of Labor Statistics*.


Occupancy
