Chattanooga is the **92nd** largest multifamily market with **36,105** completed units and **10,928** units in development, **1,974** of which have already broken ground.

Advertised **rents** are at \$1,360, up 0.4% ▲ from the previous year placing Chattanooga at 90th overall in year-over-year rent growth.

Multifamily housing **demand** has been positive with **1,420** ▲ units absorbed over the past twelve months. Absorption increased by **892** ▲ units from the previous year's absorption gain of **528** ▲ units.

Employment in Chattanooga has grown by 0.4% ▲ over the past 12 months, while hourly wages have risen by 3.6% ▲ YoY to \$28.05 according to the *Bureau of Labor Statistics*.
