
Baton Rouge is the 86th largest multifamily market with 43,187 completed units and 5,277 units in development, **1,610** of which have already broken ground.

Advertised rents are at \$1,156, down -0.1% ▼ from the previous year placing Baton Rouge at 100th overall in year-over-year rent growth.

Multifamily housing demand has been positive with 517 A units absorbed over the past twelve months. Absorption decreased by -232 ▼ units from the previous year's absorption gain of **749** ▲ units.

**Employment** in Baton Rouge has grown by **1.4**% ▲ over the past 12 months, while hourly wages have risen by 9.3% A YoY to \$33.16 according to the Bureau of Labor Statistics.
