



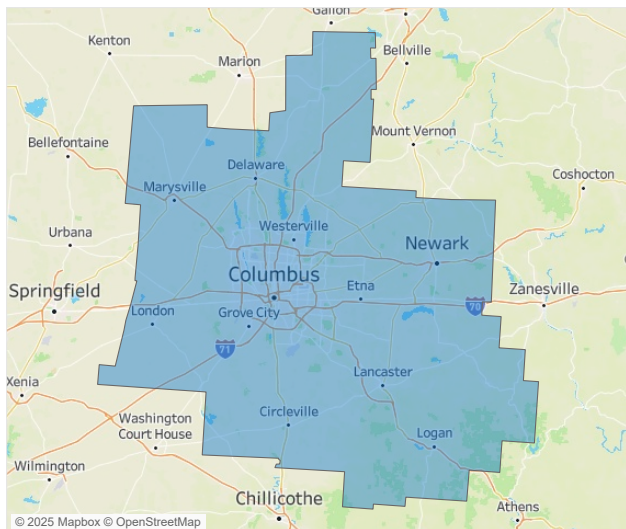

Columbus

Columbus is the **29th** largest multifamily market with **197,889** completed units and **49,630** units in development, **10,480** of which have already broken ground.

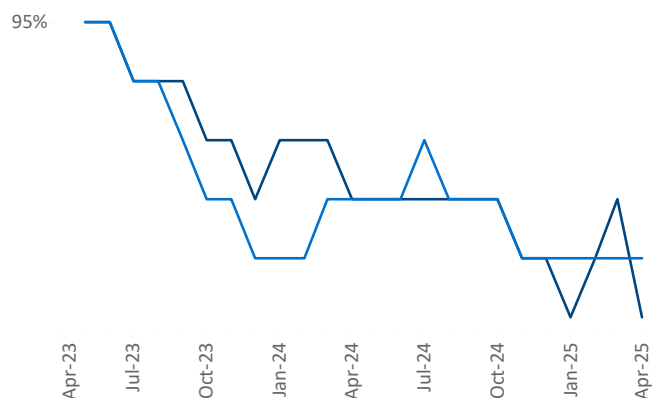
Advertised **rents** are at **\$1,357**, up **3.7% ▲** from the previous year placing Columbus at **19th** overall in year-over-year rent growth.

Multifamily housing **demand** has been positive with **8,048 ▲** units absorbed over the past twelve months. Absorption increased by **2,261 ▲** units from the previous year's absorption gain of **5,787 ▲** units.

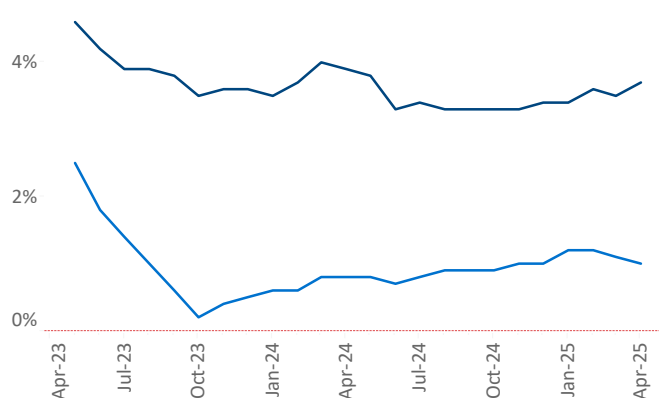
Employment in Columbus has grown by **1.6% ▲** over the past 12 months, while hourly wages have risen by **6.0% ▲** YoY to **\$33.05** according to the *Bureau of Labor Statistics*.

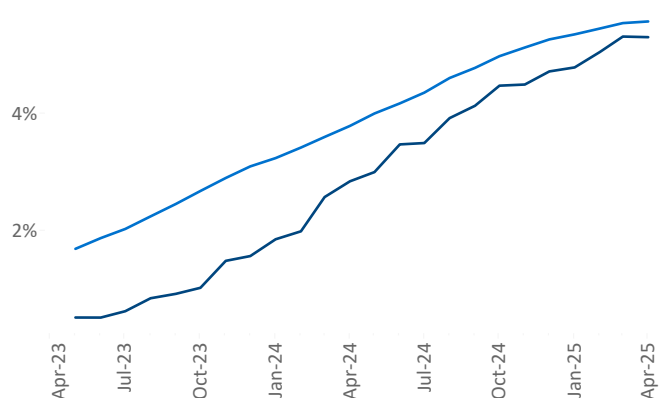
Occupancy
