





Jackson

Jackson is the **101st** largest multifamily market with **30,758** completed units and **1,430** units in development, **0** of which have already broken ground.

Advertised **rents** are at **\$1,213**, up **3.9% ▲** from the previous year placing Jackson at **15th** overall in year-over-year rent growth.

Multifamily housing **demand** has been positive with **479 ▲** units absorbed over the past twelve months. Absorption increased by **449 ▲** units from the previous year's absorption gain of **30 ▲** units.

Employment in Jackson has grown by **2.2% ▲** over the past 12 months, while hourly wages have risen by **4.0% ▲** YoY to **\$28.84** according to the *Bureau of Labor Statistics*.
