

**Richmond - Tidewater** is the **20th** largest multifamily market with **263,428** completed units and **61,566** units in development, **6,627** of which have already broken ground.

Advertised **rents** are at \$1,595, up 2.6% ▲ from the previous year placing Richmond - Tidewater at 40th overall in year-over-year rent growth.

Multifamily housing **demand** has been positive with **8,702** ▲ units absorbed over the past twelve months. Absorption increased by **1,756** ▲ units from the previous year's absorption gain of **6,946** ▲ units.


**Employment** in Richmond - Tidewater has grown by **0.8%** ▲ over the past 12 months, while hourly wages have risen by **7.4%** ▲ YoY to **\$34.13** according to the *Bureau of Labor Statistics*.
