





**Toledo** is the **91st** largest multifamily market with **37,723** completed units and **3,155** units in development, **676** of which have already broken ground.

Advertised **rents** are at **\$995**, up **2.9%** ▲ from the previous year placing Toledo at **32nd** overall in year-over-year rent growth.

Multifamily housing **demand** has been positive with **97** ▲ units absorbed over the past twelve months. Absorption decreased by **-150** ▼ units from the previous year's absorption gain of **247** ▲ units.

**Employment** in Toledo has grown by **1.1%** ▲ over the past 12 months, while hourly wages have risen by **5.2%** ▲ YoY to **\$33.66** according to the *Bureau of Labor Statistics*.
