



San Antonio
November 2025



San Antonio is the **22nd** largest multifamily market with **243,642** completed units and **45,297** units in development, **12,830** of which have already broken ground.

Advertised rents are at **\$1,235**, down **-2.7%** from the previous year placing San Antonio at **114th** overall in year-over-year rent growth.

Multifamily housing demand has been positive with **9,129** units absorbed over the past twelve months. Absorption increased by **1,047** units from the previous year's absorption gain of **8,082** units.

Employment in San Antonio has grown by **1.0%** over the past 12 months, while hourly wages have risen by **5.0%** YoY to **\$32.19** according to the *Bureau of Labor Statistics*.
